Sub: - Creation of additional Division and Ranges in jurisdiction of Belapur CT/CX Commissionerate and designation of Officers of CGST & CX Mumbai Zone, as 'Maritime Commissioner'- Reg.

Attention of the trade is invited to the Trade Notice No.1/2017-CGST & Central Excise, Trade Notice No.01/2017- Central Tax and Trade Notice No.2/2017 all dated 21st June'2017, issued under F. No. II/39-17/GST/CCO/MCX-I/2017, by this office.

Consequent upon the formation of CGST & CX Mumbai Zone in the GST regime, the jurisdictions of the erstwhile Central Excise & Service Tax Commissionerates have been reorganized as CGST & CX Commissionerates, as indicated in the above mentioned Trade Notices.

As a trade facilitation measure, the respective officers of the rank of Deputy/Assistant Commissioner of the following Division of the CGST & CX Commissionerate are hereby designated as the "Maritime Commissioner", for the respective jurisdiction as indicated in Table-I below:-
