**ESTABLISHMENT ORDER NO. 17 /2017**


The promotion of Shri. Shajan Anthony Ammuthan as Superintendent of Central Excise (now Central Tax), is issued under F.R. 22 till he completes his remaining tenure in CSI Airport, Mumbai upto 10.07.2018.

On repatriation from CSI Airport he will join at Chief Commissioner's Office, CGST & Central Excise, Mumbai Zone for further posting.

Other conditions mentioned in Establishment order No. 23/2017 dt. 10/03/2017 remains unchanged.

The Proforma Promotion is granted subject to the condition that the officiating pay drawn in the higher post should not exceed the maximum of pay scale in ex-cadre post. If it exceeds, the officer will be reverted to his cadre, within six months. Concerned CSI Airport authorities shall ensure compliance of this condition.
