2. The promotion is made purely on ad-hoc basis in terms of the Hon'ble Tribunal's Order dated 03.04.2017 in M.A. No. 232/2017 in O.A. No. 588/2014 amending the Interim Order dated 26.09.2014 (issued on 17.04.2017). The above ad-hoc promotion will not confer any right for regular promotion and this office reserves the right to cancel the ad-hoc promotion and revert the officer at any time to the post from which she was promoted.

3. No pay fixation will accrue to the officer if she has been granted financial upgradation to the pay scale of Superintendent CGST & Central Excise Gr. 'B'.

4. The promotion of the Inspector of CGST & CX to the grade of Superintendent CGST & CX Gr.B is subject to the outcome of various SLP's pending in the Hon'ble Supreme Court on the issue of seniority in the grade of Inspectors and any other orders of the Hon'ble CAT, Mumbai Bench on the said issue.

5. The above Order is issued, subject to the final outcome of the decision of the Hon'ble Tribunal in O.A. No. 588/2014. The above promotion is also subject to the outcome of the WPCT No. 261/2008 filed by Shri Samiran Roy & ors. v/s. Union of India in the Hon'ble Calcutta High Court and final outcome of implementation of DOPT's O.M. dated 10.08.2010 under No. 36012/45/2005-Estt(Res.).

6. The officer will be on probation for a period of two years in terms of Ministry's circular No. 91/88 dated 25/04/1988 issued under F.No. 12/91/88-Coord.

7. The Commissionerate shown against the names of the officer is as per the report received. There may be instances where officer, on the date of issue of order, is transferred to other Commissionerate. In such cases, the officer may be allowed to join at her present place of posting.

8. She should join latest by **31.07.2017**, positively. If she fails to join by **31.07.2017**, it will be deemed as her refusal and the promotion order will be cancelled without any further intimation.
