3. All new entrants will be governed by the Contributory Pension System introduced vide Ministry's letter F.No.12/104/2003-Coord (Circular No. 72/2003) dated 22.12.2003.
4. The pay of the above said candidate may be drawn from the date of joining mentioned above, as no pay has been drawn from this Chief Commissioner's Office.
